

## Nationwide measures to contain the Corona Pandemic



The following measures will come into force throughout Germany from November 2, 2020. They are valid until the end of November.

## Reasons

- Exponential spread of the coronavirus.
- Contacts can no longer be fully traced.
- Further increase of the infection rate leads to overtaxing of the health care system.

## Contacts



- Reduce contacts to a minimum
- Stay in public with maximum 2 households, maximum 10 persons
- No celebrations in private or public space

#### Work



- Home Office wherever it is feasible
- Hygiene concepts adapted to the occurrence of infections

## Gastronomy



- Restaurants, bars, clubs, pubs etc. will be closed
- Exception for meals for pickup or delivery
- Company canteens still open under hygiene requirements

## Travel



- Restaurants, bars, clubs, pubs etc. will be closed
- Exception for meals for pickup or delivery
- Company canteens still open under hygiene requirements

## Aid measures



- Emergency aid for affected companies and businesses is provided by the Federal Government.
- KfW fast loans for enterprises with less than 10 employees

## Risk Groups



- Protective measures in Hospitals, Nursing Homes, Seniors and Disabled Facilities.
- No isolation of the affected persons.
- regular SARS-CoV2-Fast Tests for Patients and Visitors.

- Reduce personal contacts by 75%.
- Reduce the incidence of infection.
- Reduce the number of new infections to <50/100,000 inhabitants.</li>
- Celebrate Christmas with family and friends.

## Schools & Kindergartens



- Remain open
- Further protective measures by federal states

## Retail



- Remains open under hygienic conditions
- Maximum one customer on 10 sqm sales area
- Controlled access
- Avoid queues

## Service



- Cosmetic studios, massage practices, tattoo studios, etc. will be closed
- Medical treatments (e.g. physiotherapy or occupational therapy, medical foot care) possible
- Hairdressing salons still open under hygiene conditions

## Free time



- Events that serve entertainment purposes are not permitted
- Cultural, sports and leisure facilities will be closed.
  For example:
- -Theaters, Operas, Concert Halls, Museums
- Trade Fairs, Cinemas, Amusement Parks
- Providers of Indoor and Outdoor Leisure Activities
- Arcades, Casinos, Betting Shops
- Prostitution Facilities, Brothels
- Leisure and Amateur Sports Facilities, Swimming and Fun Pools, Spas, Saunas
- Gyms
- Sports with a max. of 2 people or one household allowed.Professional sport without
- spectators
